

WESTPOINT HARBOR – FEE SCHEDULE (EFFECTIVE JULY 1, 2017)

Fee Schedule: The following fees are based on LOA (length over all including overhangs, swim steps, bow sprits and davits) or slip length, whichever is greater.

Guest Fee: Vessel length (LOA):

Boat/trailer dry storage: Must be in good condition and includes use of launch ramp.

15 f space \$75.00 per month

20 f space \$100.00 per month

25 f space \$125.00 per month

30 f space \$150.00 per month

35 f space \$190.00 per month

40 f space \$220.00 per month

Daily Rate for trailer storage and use of launch ramp - \$10.00/day

Storage lockers 10 foot @ \$130.00/mo 20 foot @ \$260.00/mo

Kayak storage: \$15.00/month (members only)

Laundry: \$25.00/month/person
Daily Rate; \$10.00 per day

High Speed Wifi: \$100 refundable deposit for hardware
\$50.00/month, no contract

Key Fobs: \$25.00 refundable deposit for each key fob after two.

Application/License Agreement: Prior to assigning a berth, a Permanent Slip Application must be completed by prospective tenants. The application should include a **recent photo** of the vessel, proof of **insurance**, and a copy of the vessel **registration/documentation**. Upon approval, a License Agreement will be completed by the vessel owner and harbormaster.

Deposit: A security deposit equal to 1.5 times the monthly fee is required prior to bring the boat into the Harbor. Deposit is refundable with 30 days advanced notice of departure, less any outstanding balances or charges.

Live-Aboard Fee: Live-aboard berths are limited to 10% of all slips, and such assignment is required for any regular overnight stays of four days per week or more. The live-aboard fee for one or two people is \$375 in addition to the regular slip fee. Additional people are an additional \$100 a month per person.

Transient Fee: Transient vessels may apply for berthing for a maximum of four months with live-aboard privileges. The Transient fee for one to two people is \$375 in addition to the regular slip fee. Additional people add an additional \$100 a month per person.

Extended-Stay Fee: Extended Stay berths are limited to 10% of all slips. Owners who have a permanent land residence and wish to stay aboard 3 days per week or less on a regular basis may apply for Extended-Stay status. The Extended Stay fee is \$175 in addition to the regular slip fee.

Commercial Photography and Facility Use Fee: Contact Harbormaster. All arrangements must be made in advance with the harbor office.

Utilities: Electricity is metered at the dock box and charged based on PG&E rates.
