Application/License Agreement: Prior to assigning a berth, a Permanent Slip Application must be completed by prospective tenants. The application should include a copy of the vessel registration/documentation, recent photos of the vessel and proof of insurance. Westpoint Harbor listed as an additional insured with \$500,000 minimum liability. Upon approval, a License Agreement must be completed by the vessel owner(s) and harbormaster prior to the vessel's arrival in the harbor.

Deposit: First month's fee and security deposit equal to 1.5 times the monthly fee is required prior to bringing the boat into the Harbor. Deposit is refundable with 30 days advance notice of departure, less any outstanding balances or charges.

Live-Aboard Fee: Live-aboard berths are limited to 10% of all slips, and such assignment is required for any regular overnight stays exceeding two days per week. The live-aboard fee for one or two people is \$465 in addition to the regular slip fee, and additional people are \$110/month/person.

Transient Fee: Transient vessels may apply for berthing for a maximum of four months with live-aboard privileges. The Transient fee for one to two people is \$465 in addition to the regular slip fee. Additional people are \$110/month/person.

Extended-Stay Fee: Extended Stay berths are limited to 10% of all slips. Boat owners who have a permanent land residence and wish to stay aboard no more than 3 days per week on a regular basis may apply for Extended-Stay status. The Extended Stay fee is \$215/month.

Commercial Photography and Facility Use Fee: Contact Harbormaster. All arrangements must be made in advance with the harbor office.

Utilities: Electricity is metered at the dock box and charged based on PG&E rates.
